SYRIA L.T. - P. G. Thurs. Nov. 29-51.

The government of Syria was overthrown today, the latest upheaval in that near eastern country.

Also -- the quickest and most surprising. Yesterday, a new government was installed at Damascus - headed by Premier Maaruf Dawalibi. Then, a few hours later, the new Premier and his cabinet were deposed by an Army Coup D-Etat. In again, out again - at high speed.

All engineered by Lieutenant Colonel Adeeb Shishakli, called the Syrian strong man.

The eruption is all the more interesting, because the deposed Premier was - anti-Western. He stood in opposition to the Middle Eastern Defense Par Pact proposed by the United States, Great Britain, France and Turkey. The Lieutenant-Colonel-strong-man, on the contrary, favors a pro-western policy, in return for military supplies.

He has an interesting history, this Adeeb
Shishakli. -- La came into prominence in the Moslem
strife with Israel, several years ago. Leader of a
group of Galilean Guerrillas that campaigned against

the Israeli. Which brought him the fore in Syria. Thereafter, backed by his band of guerrillas, he rose high in what is called the "colonel's group". A military clique that has a military clique that has engineered one coup d'etat after another, overthrowing four governments during the time since the Palestine war.

This latest followed a long political crisis - Syria left wax without a government for twenty-three days. Then, at last, a Premier and cabinet assumed power, only to be overthrown a few hours later by the Lieutenant grace Colonel strong man. He accuses the fallen government of planning to merge Syria and with Iraq, under the King of Iraq.

## SIAM FOLLOW SYRIA

We have the same sort of news from another part of Asia, Siam. This was a day of two governments overthrown -- by military revolt. ( At Bangkok, the top generals and admirals of Siam overthrew Premier Pibul Songgram, in a bloodless coup d'etat. They claim he failed to suppress Communism and end corruption The new head of the government is Lieutenant General Sriyanon, commander of the police -- the police being the largest armed force in Siam. The country has had a series of per political overturns. The deposed Premier, Pibul Songgram, seized

The country has had a series of pre politic overturns. The deposed Premier, Pibul Songgram, seiz power four years ago - and only last spring was the target of an attempted coup d'etat. He was kidnapped by rebels of the Navy. But the other armed forces remained loyal, especially the police - and the revolt was crushed in fierce fighting. This time, however, all the armed forces joined against him - and he was overthrown today.

The coup d'etat is the more dramatic, because it occurs just as the King and Queen of Siam

return to their country. They were in Switzerland for a visit - and, right now, are aboard ship, expected to land at Bangkok on Sunday. Their Siamese Majesties will find a new government - which, however, promises to support the Monarchy.

A dispatch from Indo-China states that the former Commander of Communist Forces in Cochin China, has been killed in battle. "Which, says the dispatch," represents a sinister deed of the Reds - with angles of "Titoism."

The former Communist Commander was dismissed from his post recently - charged with failure to carry out orders from Political Commissars of the Reds.

"Titoism," they called it. Then, to get rid of him, they betrayed him, and sent him to his death.

The story is that the deposed Commander, together with a Colonel also dismissed for "Titoism" - was escorted on a forcel march of twenty-three days, until the party reached a section where anti-Communist patrols were active. There the recent Red Commander was put in a spot where he was cut down by the fire of anti-Communist guns.

## KOREA EXPLOSION

Tonight news tells of a devastating explosion at the South Korean port of Pusan, which was the key point of the old beachhead. An amaunition storage place blew up with three violent blasts.

Early reports state there were many casualties but, apparently, the Americans at Pusan escaped without fatalities.

At this hour there is no explanation of what caused the three blasts that demolished the great amunition storehouse.

In the truce talks at Pan Mun Jon - the Reds display some sign of yielding - in the latest deadlock. Yesterday, they were insisting on - evacuation of all foreign troops from Korea. Today they stepped down, were talking about - a "gradual withdrawal."
