The Next Five Years: Strategic Plan 2018–2023



MARIST COLLEGE IS AT AN EXCITING POINT IN ITS HISTORY. The first students have begun their studies in our new Doctor of Physical Therapy Program, and this spring our Physician Assistant Program will graduate its first class. Our student body is stronger academically and more diverse than ever, and the College is poised for continued growth in our academic programs and degree offerings. Like any organization, we need to periodically look inward to define and redefine who we are and how we fit in, both in our home in the Hudson Valley and around the world. In this spirit, we recently developed a new five-year strategic plan to guide our way forward.

The new plan focuses on three key areas: student success, innovation, and advancing the social good. I believe that student success is measured by more than grades or salary in a first job. At Marist, we help our students fully develop their intellect, character, and skills. The College has a firm belief in the power of experiential education: extending learning beyond the classroom is key to intellectual development and critical thinking. Marist also emphasizes the importance of international study; with more than half of our students taking part in a study abroad experience. Through our campus in Florence, Italy, and the scores of study abroad programs we offer, students leave Marist with a more expansive view of the world and their place in it.

Marist has long enjoyed a reputation as an innovative college. We were working with IBM before such partnerships were common, and we've never stopped innovating. During the past year, we launched our first doctoral program, a minor in cybersecu-

rity, and a Center for Social Media. Moving ahead, we're developing a Center for Innovation to facilitate experimentation, problem-solving, and collaboration.

Social good has always been at the heart of Marist's mission. Imprinted into the College's institutional DNA by the Marist

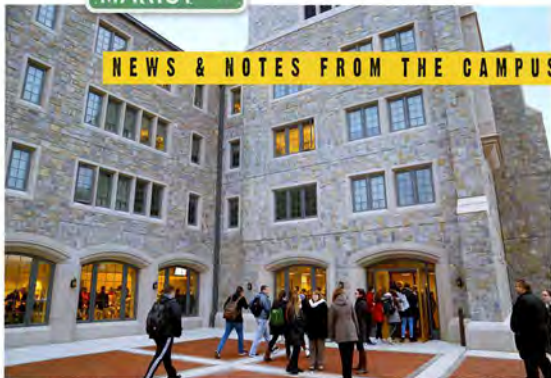

New Student Dining Center Opens


MARIST UNVEILED its newest building and an exciting local business partnership in January 2018. The College's new North Campus Dining Center houses an on-campus location for Poughkeepsie's own Rosticceria Rossi and Sons Deli.

The new location provides some of the deli's most popular dishes, including vodka chicken and signature sandwiches. Consistently hailed as a favorite among Marist students, Rossi's has also been featured in BuzzFeed as a top college-town restaurant and in Spoon University as "the most raved-about deli in Poughkeepsie."

As part of the largest capital project in the College's history, the North Campus complex brings enhanced community space for students, faculty, and staff to Marist. In addition to housing residential students during the academic term, the new facilities are designed to support academic initiatives such as Marist's summer Pre-College programs for high school students. When final landscaping is completed this summer, the

lawns and open space will provide unique campus spaces engaging Marist's Hudson River viewshed.

The new complex will also make it easier for Marist to host conferences and large-scale events. "The College is deeply commit-

ted to the economic health of the Hudson Valley," said Dr. Geoffrey Brackett, Marist executive vice president. "Having the infrastructure in place to hold events and welcome guests from outside the area plays a key role in the economic engine of the region."

Renowned scholarly press De Gruyter has published a book by **Dr. Joseph Kirtland**, professor of mathematics. Complementations of Normal Subgroups is an exhaustive look into a specific area of group theory, one of the major foundational areas of mathematics.

Dr. William Van Ornum, professor of psychology, has written the biography *Eugene Kennedy: A Man, the Catholic Church, and the Life of Faith* (Wipf & Stock, 2017).

Assistant Professor of Marketing **Vernon Murray** and Associate Professor of Psychology **Sherry Dingman** took part this past summer in a meeting on human trafficking organized by the United Nations General Assembly. They attended the session as representatives of Fang Protective Services, a nonprofit organization that has "consultative status" in the Economic and Social Council of the UN, in the area of global security training for humanitarian aid workers. Along with their service to Fang, the two professors are involved in research on human trafficking. In spring 2019, Murray will offer a special topics course through the School of Management, "Human Trafficking Marketing and Countermarketing." Students will learn about the marketing aspects of trafficking and how to use social marketing tools and concepts to oppose the efforts of human traffickers.

Seniors **Francesca Treglia** and **Ryan Guzhayn** have been accepted into the selective program Teach For America, a nonprofit that places teachers in high-need classrooms across the country. Treglia, a Higher Education Opportunity Program student and psychology major, will teach in her hometown of New York City. Guzhayn, who is majoring in political science, will teach in Richmond, CA. Acceptance into TFA is competitive. For fall 2017, the organization received 49,000 applications and accepted 15 percent.

Book Examines FDR's Last 100 Days

DR. DAVID B. WOOLNER'S NEW BOOK, *The Last 100 Days: FDR at War and at Peace*, paints a detailed portrait of the final 100 days of Franklin D. Roosevelt's life and presidency. It shows how FDR—a man of 60-plus years in a precarious state of health—coped with the day-to-day demands of office during one of the most critical periods in American history.

In *The Last 100 Days Woolner*, a senior fellow and resident historian at the Roosevelt Institute and a professor of history at Marist, argues that FDR foresaw the globalized world to come and the central place of the U.S. within it. Above all else, this made the establishment of the United Nations and securing the American public's support for the fledgling organization imperative. But FDR also pursued a number of other less well-known initiatives that he was never able to fulfill, including the establishment of a Jewish homeland in Palestine. While balancing these and other urgent matters, FDR tried his best to adhere to the rest regimen that his two primary physicians insisted was critical to his survival. He understood that he was ill, as did those closest to him, but the standard line from his doctors to the public was that he "was in fine health for a man his age."

Drawing upon previously untapped sources, Woolner depicts FDR as a much diminished man, often near the point of physical exhaustion, yet determined to press on and achieve the goals he set for himself, his nation, and the world. These final 100 days set in motion some of the most important and long-lasting consequences of FDR's transformative presidency, which fundamentally changed the way American citizens view the role of government, as well as America's role in the world. **D**

Two Marist Seniors Awarded Fulbright Fellowships

MARIST STUDENTS ANDREW BEST '18 and LAURA GARDNER '18 have each been awarded a Fulbright English Teaching Assistantship.

The graduating seniors will teach English in Malaysia and Spain, respectively. Best is a psychology/special education major from Montclair, NJ, while Gardner is a Spanish/adolescent education major from Thornwood, NY. In recent years, Marist has had tremendous success with this nationally competitive award, with 24 students winning a Fulbright in the last 11 years.

"The Fulbright Program, the U.S. government's flagship international educational exchange program, is sponsored by the Bureau of Educational and Cultural Affairs of the U.S. Department of State. "We're proud that Marist students continue to successfully compete for our nation's most competitive fellowships," said Marist President David Vellen. "This record of success is the result of our students' hard work, as well as the excellent preparation they receive at Marist, including the mentorship of our dedicated faculty. **D**

The collection contains more than 50,000 titles of music, well in excess of 250,000 parts or pages to be digitized. The library also contains phonograph record albums produced by Hoe, their master recordings, additional recordings on audiotape, and correspondence from researchers and music aficionados from around the globe, all requesting access to the collection.

Because of his long friendship with Hoe, Himmelberger knows the collection inside out and is one of the few people who understands how its contents are catalogued. From a young age Himmelberger gained a vast knowledge of band-march music thanks to his father, who frequently played recordings of marches at home. Himmelberger began playing in community bands at age 8 and by 22 was performing as a member of the U.S. Army Field Band in Washington, DC.

Hoe and Himmelberger met in 2013 when Hoe approached the leadership of the U.S. Army Field Band on a mission to record distinguished bands performing the music he had collected, much of which had never been recorded. Himmelberger offered to help with the project, boldly adding that he knew as much about band marches as anyone alive. Hoe tested the 22-year-old whippersnapper, asking him to name 10 march composers and not to include the most famous, Sousa. Himmelberger proceeded to rattle off not only 10 but 15 names. Hoe was impressed enough to add Himmelberger to the list of enthusiasts to whom he mailed the long-playing (LP) records he produced. Following Hoe's death in 1982, Himmelberger remained close to the

Hoe family and worked diligently to preserve and advance the Hoe music library.

Also invaluable in making the collection accessible is William H.

Rehrig, a school band director and band historian. Rehrig prepared materials in the library for digitization.

Lucas Schissel, senior specialist of music in the Library of Congress's Music Division, will lead the preservation of the physical collection of the Hoe library. "Robert Hoe

Preserving Music History

Robert Hoe V assembled the world's premier private library of sheet music for concert and marching bands. Now, through a collaboration involving his heirs, Marist College, and the Library of Congress, his unique collection will be digitized and made available to the public.

ROBERT HOE V spent his life devoted to concert and military band music—discovering it, recording it, and sharing it with others. A successful businessman and philanthropist who lived in Poughkeepsie, he started his musical journey as a boy playing the cornet. He switched to the euphonium in college and became enamored with band marches. Subsequently he assembled the world's most revered private library of sheet music in that genre. He traveled the world collecting it, financed recordings of it by some of the world's most renowned bands, and mailed these recordings to other enthusiasts at his own expense. Now, through an unusual collaboration involving his heirs, Marist College, and the Library of Congress, his painstakingly collected internationally renowned library will be digitized and made available to the public.

In late 2017, Marist received generous gifts totaling \$200,000 from Robert Hoe VI, his sister Polly Diane Hoe, and the Hoe

Foundation to digitize the library. The physical collection, currently stored in an office in one of the Hoe family businesses, will be housed in the Library of Congress.

The collection, according to Marist Director of Music Art Himmelberger, is the largest privately owned library of historic wind-band music in the world. "It took a lifetime to create the library," said Himmelberger. "It would take several lifetimes to thoroughly absorb all that is there."

The Robert Hoe Music Collection consists of sheet music for marching and concert bands written by a plethora of well-known composers. Significant components of the collection include original John Philip Sousa manuscripts and parcels of the band libraries of two historically renowned bandmasters, David W. Reeves and Alfredo Tommasino.

was a longtime and valuable friend of the Music Division at the Library of Congress," Schissel said. "His passion for band music was so wonderfully shared through his historic series of recordings which were sent free of charge throughout the world. We're delighted that the Hoe family is making this large and historically important collection available to all scholars and lovers of fine band music everywhere—they are truly carrying on the great tradition of their father."

"It was very exciting to finalize the agreement with the Hoe family," said Dr. John Ansley, director of Archives and Special Collections at Marist. "It is an incredible opportunity to be able to continue to work with Bob and Diane, and now the Library of Congress. This will be the first time Marist has had the opportunity to collaborate with the Library of Congress, one of the world's greatest research facilities."

The signing of the funding agreement at Marist was a celebration, complete with a bottle of Champagne and background music from one of Hoe's recordings.

"When I hear that, it's like my father is here," said Diane Hoe.

"My father cared so much about this kind of music," she added. "He used to say 'People love band music. I want to make this music available to people so they can love it as much as I do.' To have it come together like this with Marist is just marvelous."

The significance of the day brought tears to Bob Hoe's eyes.

"We've put in place a mechanism for this to be accessible," he said. "This is exactly what my father would have wanted."

Bob Hoe: Keeper of the Heritage

Throughout the history of the concert band, there have been many who have been important to its continued growth and development. Patrick Gilmore, John Philip Sousa, and Frederick Fennell have all made their indelible mark on the history of the band. There is one other, who, while not a conductor or performer, has had a great deal of influence on the direction of bands and band music in the 20th century.

Bob Hoe, born to a family of businessmen, began playing euphonium at an early age and played it in the Pomona College Band. After graduation, he was exempted from military service because of an ear problem and was employed at a steel mill during World War II. Just before the end of the war, Bob and his wife, Marilyn, moved to Poughkeepsie, NY, where he opened an architectural woodworking firm. This firm prospered and became the largest of its kind in the United States. In 1964, Hoe dissolved the woodworking firm in order to devote his time to a bowling business he had obtained. The new corporation, Marib-Bob Bowling, operated its bowling allies in the greater Poughkeepsie area.

Bob Hoe always had a keen interest in band music, particularly marches. While amassing a varied collection of band recordings, he also acquired copies of much of the sheet music which the bands had used for making recordings. As a euphonium player (a "youffer," as he described himself), he was dismayed because there were no adult bands near his Poughkeepsie home. Moreover, the demands of his business were such that he could not attend rehearsals and concerts on a regular basis. As a result, he began collecting band records. He collected not only commercial and private recordings, but also tapes of concerts. Concurrently, he began to collect the printed parts for the music on the records. What developed was a unique hobby of playing along with the records on his euphonium (and other brass instruments) using the same edition of the music that was on the records. Eventually, Hoe became acquainted with many kindred souls who helped him with the collection of music and recordings.

Hoe visited bands with major music libraries and made copies of music that was not readily available, and his own personal library became quite large. He made several trips to Europe, where his quest for music reaped unexpected dividends. For example, he discovered a large number of rare German marches in the basement of a theater in Wevel, Germany, and still others at a German radio station. In Spain, he found many piano duets that were unknown outside of that country. He made trips in France, England, and Italy with similar results. In the United States, he acquired the libraries of several defunct bands.

He also took on the challenge of sorting thousands of uncatalogued pieces of band music in the basement archives of the Library of Congress in Washington, DC. With my help and that of several other band scholars, he searched through more than 4,000 boxes of music to locate titles for his collection. The library subsequently catalogued these pieces.

The next step was to interest bands in making commercial recordings of some of these newly discovered works. This turned out to be very difficult, but two bands cooperated. The Scots Guards Band of England produced two all-Sousa albums, and the British Band of the Life Guards produced an album of the marches of Karl L. King, using pieces selected by King himself.

Hoe's inability to interest other bands in making commercial records of his music greatly frustrated him. In his mind, there was only one solution: to produce the records himself.

This was born the Heritage series of LP records. The first series of 15 albums, now available on CD from Naxos, was recorded by the U.S. Navy Band. The records were distributed free of charge to more than 300 people on Hoe's mailing list. Included were band fans, band conductors, and band composers. All he asked in return was that each recipient write him a letter with their evaluations and thoughts about the music and composers.

The Heritage series grew to a total of 265 LP records, all produced at Hoe's expense. Among the bands that recorded these albums were the U.S. Army Field Band, the U.S. Coast Guard Band, the U.S. Marine Band, the U.S. Military Academy Band, the Allentown Band, le Musique du Royal 22e Regiment of Canada, the Eastern Regional Band of the Norwegian Defense Forces, the Grenadier Guards Band of Great Britain, le Musique de la police Nationale de France, the Home Guards Band of Göteborg, Sweden, the Luftwaffen Musikkorps Band of Germany, the Scots Guards Band of Great Britain, the Phillips Band of Holland, and the Australian Police Band.

Bob Hoe's influence on bands and band music lives on today, some 35 years after his death. Major publishers are issuing contemporary editions of some of the historically valuable music in the Heritage series. The recipients of the records and the conductors of the bands maintained friendships long after his death. The original LPs of the Heritage series are collectors' items, and the Hoe family has given Naxos records to produce CD versions of some of the original albums. Bob Hoe was truly a keeper of the heritage.

Celebrating Those Who Support Scholarships

MARIST HOSTED THE FIFTH ANNUAL CELEBRATION OF SCHOLARSHIPS LUNCHEON on Oct. 28 in the Murray Student Center. More than 50 scholarship recipients attended to thank benefactors who endowed scholarships and support annual giving scholarships.

Expanding support for scholarships is one of the College's highest fundraising priorities. Scholarships help Marist attract the best and the brightest, assist in decreasing student debt, inspire others to invest, and teach the importance of philanthropy. They also serve as a lasting way for donors to honor those they cherish and respect.

Honoring NYPD Officers and Families

Among Marist's scholarship funds is one with a poignant history. On Aug. 17, 1947, Patrolman Thomas J. Gargan of the New York Police Department was killed in the line of duty while responding to a burglary in Greenwich Village. He was a highly decorated officer who received the Combat Medal and was posthumously awarded the NYPD's

Medal of Honor. Gargan left behind his wife, Margaret, and four sons.

Seeking a fitting memorial, family and friends initiated a scholarship in Tom Gargan's name to support local students from families who served the NYPD. About 25 years ago, Marist was approached by one of Tom's sons, James V. Gargan Sr. '63, about accepting the longstanding endowment to help Marist juniors or seniors whose parents or grandparents were members of the NYPD. In ensuing years, the names of Sgt. Finbar Devine, a partner of Tom Gargan, and Joseph Dolan, a close family friend, were added to the fund to create the Finbar Devine/Tom Gargan/Joseph Dolan Scholarship.

Nearly 60 years after their father's death, Jim Gargan and his brother, Bill, continued to support the scholarship. Jim, who passed away in February 2017, attended the College as a Marist Brother, earning a degree in English. He went on to teach secondary and

college English before earning a law degree at University of Michigan Law School as a layman. Among other legal pursuits, he was a longtime counsel for the New York Cotton Exchange.

Bill Gargan and Jim's wife, Ginny, attended the Celebration of Scholarships luncheon where they met Liam Moyles '18, a current recipient of the scholarship. Moyles, whose family has a long commitment to public service, expressed his gratitude to the Gargan family for their support.

"I am honored to be a recipient of this scholarship," he said. The scholarship is not only honoring its namesakes but helping Moyles achieve his dream of carrying on a family tradition: serving in the NYPD. He already has held two internships with the department.

"I hope to be in the summer 2018 academy class," said Moyles, "following in the footsteps of both my grandfathers, my mother, and my brother." 📌

Longtime Faculty Establish and Sustain Innovative Internship Program

TWO LONGTIME FACULTY MEMBERS have established and continue to generously support an internship program that not only gives students hands-on experience but also helps the community surrounding Marist.

Margaret Calista, former dean of the School of Social and Behavioral Sciences, and her husband, Dr. Donald J. Calista, former director of the Graduate Center for Public Policy, chose to remain anonymous when they launched and funded the Marie and Rupert Tarver Summer Internship Program in 2014. Recently they allowed the Office of College Advancement to state that they are the founders of the Tarver program, which is named for two area community leaders.

The Tarver Internship Program provides resources for faculty to implement community-based learning components in classes and students to work with area nonprofits to develop skills in their career fields.

The Calistas recognized that students were interested in working in the nonprofit sector but had to turn to other fields for summer jobs

because internships at nonprofits are typically unpaid. The Tarver program supports undergraduates, guided by a Marist faculty member, in paid internships at local nonprofits for eight weeks during the summer. The Tarver students also receive free tuition for

three credits and free on-campus housing during their internships.

The Tarver Internship Program is directed by the Center for Civic Engagement and Leadership, an initiative that originated as a joint venture between the School of Social and Behavioral Sciences and the School of Liberal Arts and is now housed in the School of Liberal Arts. The selection process for interns is competitive; between 2014 and 2017 there were 46 applicants for 18 positions. The 18 interns have helped 13 organizations since 2014.

Today, former interns are on career paths ranging from graduate school to the nonprofit sector and the corporate world. Breanna

Lechase '16 will complete an MS in education at SUNY New Paltz this year. Rosa Genetti '17 is attending the University of Michigan School of Social Work and Marissa Zuleta '17 is enrolled at Columbia University's Mailman School of Public Health. Darriel McBride '17

is completing her Fulbright grant in South Africa. Nicholas Bayer

'16 works at the

nonprofit Doctors Without Borders. Ryan Guzhnay '18 will join Teach For America (see page 4).

Melissa Enright '17 is enjoying her role in the HR department of a law firm in Manhattan. "Although I have strayed away from the nonprofit world, I feel my new position still gives me some of the same joys of working in nonprofit," Enright said. "For example, in HR, I still get the ability to work closely with others. Most importantly I have the ability to help others in their careers and professional lives." ■

The Doctor is In

Classes begin in Marist's first doctoral program, dedicated to creating the next generation of physical therapists.

LIBBETTE SCHUM '20 wants to become a physical therapist because she loves working with the human musculoskeletal system. "It's detective work to get to the root of the patient's issue," she said.

Schum, from Cortlandt Manor, NY, is one of 14 members of the inaugural class in Marist's Doctor of Physical Therapy Program, which began classes on Jan. 8.

"We are very excited about all aspects of the program—our students, faculty, college and community support, and the opportunities we have to ensure that our students receive the highest level of therapy education," said Dr. Claudia B. Fenderson, director of the program.

Marist's first doctoral program, when at full capacity, will accommodate three cohorts of 48 students each.

To Schum, the size of the current cohort is a definite advantage. "The program is great so far" she said. Having 14 in the class creates "an atmosphere of support and genuinely wanting each other to succeed."

In fall 2017, the program received approval from the New York Board of Regents and received "Candidate for Accreditation" status from the Commission on Accreditation in Physical Therapy Education. Marist's program will be eligible for full accreditation in October 2020, shortly before this initial cohort is set to graduate in December 2020.

After approvals were received, recruitment by the Admission Office and word of mouth in the regional PT community quickly brought in 67 applications. Members of the inaugural class hail from New Jersey, New York, and Washington State.

Admission criteria are very strict. Applicants must have at least a bachelor's degree with a 3.0 GPA overall as well as a 3.0 GPA in science prerequisite courses. Prerequisites are eight credits each of anatomy and physiology; biology, chemistry, and physics as well as credits in psychology and statistics. Applicants also must have a minimum of 80 hours of volunteer or work-related PT experience in at least two different settings.

Once students enroll, the rigor continues. The DPT is a full-time, 36-month, 115-credit program with a curriculum that includes gross anatomy, physiology, clinical neuroscience, pathology, prosthetics and orthotics, diagnostic imaging, and pharmacology, as well as patient management courses in the areas of cardiopulmonary, orthopedic, and neuromuscular physical therapy. The program's mission statement says "Graduates will be prepared to merge hands-on skills, ethical care, clinical judgment, and critical inquiry to promote optimal functioning of current and future clients throughout their lifespan." The program also prepares students for the National Physical Therapy Examination.

Work in a clinical setting is a critical component of the curriculum. Currently 140 organizations—including hospitals, rehab and long-term care facilities, outpatient clinics, schools, and home health care agencies—have committed to accepting Marist PT students for training.

"There are no DPT programs in this region," said Fenderson. "The physical therapists who work in area hospitals, nursing homes, special education schools, and outpatient settings were so excited about the development of our DPT Program that they are very eager to have our students for clinical experiences."

Students will complete two clinical affiliations that last ten weeks and two that last eight weeks. The DPT Program can arrange affiliations in any part of the U.S., and rotations may also be available in Italy.

One of the distinctions of the Marist program is its faculty. "We have a well-qualified faculty," said Fenderson. "The majority of our

faculty have years of experience teaching."

"There's such cohesion among this faculty," said Julie Fineman, director of clinical education. "There are places where there is a lot of competition for research time and articles. I think that we just all want to help each other. It's such a lovely environment and I think the students feel that."

Schum, who earned a BS in sports medicine from Merrimack University, has high praise for the faculty. "I chose Marist because the faculty is amazing. When I came for my interview, they were so nice and helped to ease the tension of the day. They also have diversity in specialties of physical therapy."

Another strength of the program is its state-of-the-art equipment and facilities. The research lab features the "P-Walk" platform, a sensorized walkway for analyzing gait in patients who have neurological disorders, orthopedic issues, or prosthetic devices. A "SMART-DX" high-precision optoelectronic system uses its infrared video cameras and wireless electromyography (EMG) probes for study of all aspects of a patient's movements. "Most schools do not have that," said Fineman.

In addition to this research lab, key elements of the DPT space in the Science and Allied Health Building are a gross anatomy lab, a PT skills lab, and a technologically advanced clinical simulation suite with a twin trauma bay and five exam rooms.

A cornerstone of the DPT Program's strategic plan is volunteer service, which is also part of Marist's mission handed down from the founding Marist Brothers. "I love being at Marist because they really embrace that," said Fenderson.

Students must complete a doctoral project focused on either service, research, or education. They are also required to carry out 10 hours of community service annually.

The DPT Program will use its special equipment and expertise to help the greater community. In conjunction with Mid-Hudson Regional Hospital, Fineman is establishing

a Parkinson's disease registry that will evaluate individuals with Parkinson's annually. Also planned is an annual clinic to assess local elderly residents for balance issues and suggest preventative measures. A regional prosthetics and orthotics group will partner with the DPT Program for a clinic that will help amputees improve in mobility.

The DPT faculty volunteered as a group even before students enrolled. In August 2017 they helped staff 1,200 backpacks with school supplies for the local effort "Backpacks, Supplies, and More."

Fenderson also volunteers on a personal level. In 2018, for the eighth year, she and her husband, an occupational therapist, traveled to Ecuador with the nonprofit Medical Mission Ecuador to care for residents of that country. Many Ecuadorians travel as much as 12 hours to be treated at the group's annual clinic. This year Marist DPT faculty member Dr. Yvonne Egitto joined the group for the first time. The team of surgeons, orthopedists, nurses, therapists, and other healthcare professionals pay their own way and raise money for equipment such as wheelchairs, braces, and prosthetics to give to the patients. Fenderson expects Marist students, once they have completed some clinical training, will volunteer to go as well.

The DPT Program's graduates will fill an immediate need as they enter an excellent job market. The U.S. Department of Labor Bureau of Labor Statistics has projected that jobs for DPTs are expected to grow 28 percent by 2026 nationally, a rate much faster than the average—7 percent—for all occupations.

In 2014, a report of the New York Health Workforce Data System documented a need for PTs in both the state and Hudson Valley. The report said Valley hospitals describe a 40 percent shortage of PTs, nursing homes a 50 percent shortage, and home health care agencies an 83 percent shortage. A New York State Department of Labor report predicts that by 2024, the need for PTs in the state will increase by 29.3 percent, and in the Hudson Valley by 31.2 percent.

For Lisette Schum, the rewards lie in seeing patients make progress. "I love the aspect of working with someone to reach their goals no matter how small or large they are. Watching someone be able to do something they struggled with for a long time is the best thing to witness and be a part of." ■

Growth Opportunity

WHAT STARTED AS AN ACADEMIC PROJECT by two students has blossomed into a garden on the Marist campus and an exciting learning resource for all Marist students. Alec Lee '18 and Alexa Kovlakas '17 created a vegetable garden for the College that this past fall bore its first harvest.

As students in Marist's Honors Program, Lee and Kovlakas each had to complete an honors thesis project. Lee, an environmental science major with a minor in biology, wanted to use his project as a way to gain new skills. He was interested in food production as well as ethics and social justice, so food ethics seemed like a good study subject. He began working on the project in his junior year with Dr. James Snyder, director of the Honors Program, as his advisor with the idea to create a garden in the city of Poughkeepsie.

At the same time, Kovlakas, a biomedical sciences major with a chemistry minor, was working on a thesis project with Dr. Joseph

Campisi, assistant professor of philosophy. Her project, creating a garden on campus, was inspired by work she had done for her honors Ethics of Food class, taught by Campisi. The course concerns the production, distribution, and consumption of food and encourages students to think ethically and critically about everyday decisions they make about what and where to eat. To fulfill the course requirement to engage with the community, Kovlakas weeded strawberries, tended seedlings, and prepared farm plots at the Poughkeepsie Farm Project.

"I learned a lot about myself and what goes into the food I eat," she said. "Those were the things that I wanted for students at Marist: an opportunity to grow their own healthy fruits and vegetables, to learn more about the work that goes into the foods they eat, to connect to other students with similar passions, and to reap the psychologically therapeutic benefits of gardening."

Lee and Kovlakas teamed up. They talked to local farmers, studied crop choices, created a budget, and developed a design with a landscape architect. They won approval from College administrators for a garden overlooking the Hudson River, near the Dining Hall.

Construction on the 5,000-square-foot garden began in May 2017 and finished in August. By then Kovlakas had graduated. Lee sowed the seeds and later transplanted them, a task that took two 12-hour days. Design features of the garden include raised beds and mesh fencing to preserve the river view.

The first harvest this past fall produced lettuce, kale, bok choy, turnips, strawberries, and green beans as well as lavender, basil, rosemary, and thyme.

The garden has quickly become an extension of the classroom, providing a number of opportunities for the campus community to engage. In fall 2017 the Ethics of Food seminar, taught by Snyder, worked on projects related

to the garden. In spring 2018 the Honors Program offered classes on food, biodiversity, and climate-change, each of which makes use of the garden.

"The garden provides the College with a place to learn, think, build community, and get in touch with oneself and nature," said Snyder. "This semester the Honors students are designing, budgeting, and planting two beds in the community garden. The bulk of the students in the class have never planted something before. By the end of the semester, they will be responsible for creating a working garden, and how it will be cared for over the summer. I am excited for the students, and they are looking forward to getting their hands dirty."

Also this spring, students living on the Honors floors in Champagnat Hall will plant a garden for the incoming freshman Honors students of the Class of 2022.

Campisi too will make use of the garden when he teaches the Ethics of Food class this fall. "It is one thing for students to read about agriculture and the process of producing food," he said, "but it is another to have direct, hands-on experience with the real process of growing food—the effort it involves, the knowledge it requires, the rewards that can come from such efforts."

Campisi also believes the garden has value for those in the Marist community who are not working directly in it. "So much of our food system is invisible to us—we don't see how our food is produced, how it gets to our plates. Seeing the garden on campus, making food production visible in this way, can hopefully get people to think about the production

of food, what it requires, and, ideally, such awareness may lead people to start asking questions about our prevailing food system, what impact it is having on our lives, on the environment."

Students will manage the garden after Lee graduates. The Campus Sustainability Advisory Committee will serve as an advisory board. Five of the 12 raised beds will be dedicated to growing produce for campus dining, and eight will be available for faculty and student clubs to farm, with the stipulation that 50 percent of the produce from these must be donated to an area nonprofit agency or to campus dining.

Lee's wish is that the garden will be a hub for creativity.

"I hope that once I'm gone it inspires other students to use food growth as a tool for education and innovation—providing a space for students to develop their own projects whether based on composting, education, growing plants as sustainable textiles or dyes, or even encouraging campus-wide events such as a local farmers' market held around the outskirts of the garden.

"But I hope this area becomes a wellness space too, where individuals can meditate, relax, or find joy from the space or the process of growing the food."

Marist and Sprout Creek Farm: A “Marriage of Missions”

Under an agreement with local institution Sprout Creek Farm, Marist will oversee operations of this working farm, creating new opportunities for students while continuing the farm’s educational offerings for the Hudson Valley community.

SPROUT CREEK FARM, a nonprofit working farm and education center in Dutchess County, NY, has transferred control of its operations to Marist College. The 200-acre farm produces award-winning cheese, raises a variety of farm animals, and offers numerous educational programs focused on agriculture and the environment. The farm will remain an independent nonprofit.

“As we considered ways to ensure the viability of Sprout Creek Farm in the future, we approached Marist College and were delighted that they were interested in integrating the farm into the College,” said Alice Maggini, chairperson of the farm’s board of directors.

“Sprout Creek Farm provides the College with a tremendous opportunity to establish programs for our students and faculty while continuing and enhancing the wonderful educational offerings the farm has offered this community for more than 25 years,” noted Marist President David Yellen. “Sprout Creek Farm’s central work—educating people to appreciate the rich agricultural heritage of the Hudson Valley and the United States and fostering a sense of responsibility for the future of the environment—aligns perfectly with Marist’s core mission.”

In addition to continuing the farm’s current educational programs and agricultural operations, Marist plans to invest significantly in the facilities and develop new connections between the farm and Marist’s academic pro-

grams. “Sprout Creek will play a key role in Marist’s experiential learning programs by serving as a living classroom and providing hands-on learning opportunities for students in a variety of academic disciplines,” said Dr. Geoffrey Brackett, Marist’s executive vice president.

Sprout Creek Farm was originally founded in 1982 by the Society of the Sacred Heart, which remained deeply involved after an independent board of directors was established in 2012.

“The Society of the Sacred Heart is delighted that Marist College will move Sprout Creek Farm into the future,” said Sheila Hammond, RSCI, provincial of the United States–Canada Province. “This is really a ‘marriage of missions’—the farm will continue to offer the same excellent educational and agricultural experiences for children and adults that have become beloved features of Sprout Creek.”

Marist Rowing Shines at Head of the Charles Regatta

Marist rowers posted an exceptional performance at the prestigious Head of the Charles Regatta, the largest rowing event in the world.

WHEN IT COMES TO ROWING, one thing is certain: favorable weather can lead to a successful outcome.

That's why Marist's seasoned rowing coach Tom Sanford went into the prestigious but grueling Head of the Charles Regatta in October 2017 with high expectations. The forecast called for warm and calm conditions. "The Head of the Charles is a great race, yet a brutal one. If you're out on that river on a windy or rainy day, it can be very challenging and uncomfortable for the competitors," Sanford explained.

The largest rowing regatta in the world, the Head of the Charles is in its 54th year and now attracts more than 11,000 athletes from around the globe to compete in 56 different race events. The races take place over a winding three-mile stretch of the Charles River in Boston, MA. In 2017, 20 of Marist's current rowers competed along with several alumni in various events throughout the weekend. The students represented all four class years and were geographically diverse, too—rowers hailed from Hawaii to Ireland to Washington and numerous places in between.

At the end of an unseasonably warm weekend the coaching staff (comprised of Sanford,

Taryn Wilson, Julia Rigothi '17, Campbell Woods, and Josh Stratton) had much to be happy about: the Marist rowing program walked away with medals from four events (including two from alumni).

"The athletes' execution of their race plans coupled with cooperative river conditions made for a very successful weekend," said Sanford.

The Head of the Charles Regatta rewards the top 10 percent of finishing crews in each event with medals. Competing for Marist College, the Women's Club 4+ finished 13th out of 52 and the Men's Collegiate 4+ finished 4th out of 40. On the alumni side, Andrew Hashway '07 won the Men's Master Single (30+) and Rigothi finished 2nd in the Women's Club Single.

This was Rigothi's seventh time competing in the Head of the Charles and her sec-

ond medal; she was also a nominee for the NCAA Woman of the Year Award. "My race was great, but what was really special was to be at this race as a coach for the first time," she said. "I was thrilled to see our athletes be so successful and supportive of each other throughout the two days of competition."

Marist had two other crews who raced exceptionally well but finished out of medals. The Men's Collegiate 8+ was in the top five, only 11.5 seconds out of a medal, and improved on their 2016 result by 10 places. The Women's Championship Double, competing against crews composed of international athletes, finished 13th in the field and 4th collegiately.

"It was a big weekend for our rowing program in many ways," Sanford reflected. "Our student athletes' strong performances were a testament to their hard work leading up to the regatta." 📍

Steven Rizzo '18 Named One of Four National Finalists for Award

ONE AFTERNOON THIS JANUARY, Steven Rizzo was riding in the passenger seat of a car driven by teammate Steven Morrison. They were on their way to a workout when Rizzo checked his email.

Awaiting in his inbox was a note from Ali Kenney, Marist's assistant director of student-athlete enhancement. The news contained within it certainly qualified as a pleasant surprise.

Through the email, Rizzo learned that he was named one of four national collegiate finalists for the 14th Annual Coach Wooden Citizenship Cup as announced by Athletes For a Better World. This spring, one winner will be selected at a banquet at Cobb Galleria Ballroom in Atlanta.

"I called my mom and dad, and they were ecstatic," said Rizzo, a senior on Marist's cross country and track and field teams. "Then I let (Marist director of cross country and track and field) Pete (Colaizzo) know. And then I had my best workout of the season."

The Coach Wooden Citizenship Cup is awarded to athletes who have made a great difference in the lives of others. Two high school, one collegiate, and one professional athlete earn the honor annually. Previous winners include Peyton Manning, Jack Nicklaus, Pat Summitt, Tim Tebow, and Dick Vitale.

"I was honored and humbled," Rizzo said. "Look at the past winners. It's amazing."

Over his four years on campus, Rizzo has become well-known for his enthusiastic and friendly nature. He has devoted his time to numerous causes on and off campus and has earned respect from a considerable number of facets of the Marist community.

"Rizz" is one of the most genuine student-athletes I've coached in my 27 years at Marist," Colaizzo said. "He treats everyone he encounters with the same enthusiasm and interest: his teammates, his coaches, fellow athletes and

coaches on other teams, athletic personnel and administrators, security guards, housekeepers, dining hall workers, everyone in the Marist community."

An ideal of the Marist Brothers is "doing good quietly." This applies to Rizzo and the reasons behind his commitment to service on and off campus.

On campus, one of Rizzo's most passionate causes is his role as a certified ally. Over the past two-and-a-half years, this has enabled him to provide support to members of the LGBTQ community. Off campus, he has assisted his hometown of Wappingers Falls with revitalization projects aimed at providing safer drinking water through grant-writing support. He also has volunteered his time to organizations such as Knights of Columbus, Special Olympics, and New York Blood Center. He serves as a peer mentor to Marist's student-athletes while taking part in Marist's Student Government Association and also completing three internships.

"His dedication to service is so profound that I wasn't even aware of all that he does until I saw his nomination package for this award," Colaizzo said.

Rizzo's commitment to service is not the result of someone seeking accolades or lines on his résumé. It has come from a desire to help people and causes that are close to his heart, and seeing the positive effects that have come from lending a helping hand.

"I do things because I'm passionate about doing them," Rizzo said. "I'm happy that it's my passion that's getting reflected."

An economics major with minors in business and public relations, Rizzo has excelled as a student-athlete over the past four years. In the spring of 2017, he was honored by the College Sports Information Directors of America (CoSIDA) as an Academic All-District selection. In each of his previous seven semesters at Marist, he has qualified for the Dean's List by virtue of having a grade-point average of at least 3.6. He is also a multi-year member of the Metro Atlantic Athletic Conference's All-Academic Team and Academic Honor Roll.

Rizzo has served as team captain for the past two seasons. He has played a key role on relay teams that have set school records and qualified for the IC4A Championships, and is one of just 25 runners in program history to break 15 minutes in the 5,000-meter run. This past cross country season, he battled through a painful Achilles injury to be there for his teammates.

"Steven consistently brings positivity and encouragement to every member of our campus," Marist Director of Student-Athlete Enhancement Alyssa Gates said. "He epitomizes what it means to be a Marist Red Fox

As Rizzo's time at Marist is winding down, he has devoted plenty of thought to what his future could entail. In the short term, this may include pursuing an MBA degree or gaining experience in the business world. Deeper into the future, he envisions a run for public office or an executive position at a nonprofit agency where he would have the ability to effect meaningful change.

"Steven epitomizes everything we espouse in our track and cross country program: first and foremost, excellence in academics," Colaizzo said. "Second, a strong commitment to being the best athlete and team player that he can be. Third, loyalty to the team and service to others. 'Rizz' checks every box and more."

"I'm so proud of how he has represented our program, and the fact that he made the final cut for the Wooden Award is national validation about what we already know about 'Rizz' here at Marist. The outcome doesn't matter. He's already won in our eyes." 📧

A Voyage to Volunteering

work alongside residents of the Dominican Republic and other Eastern Caribbean locations on development projects that promote human welfare. Wicks, an elementary school STEM teacher for more than 18 years in the same Long Island, NY, district, was invited on a spring 2016 cruise as part of the 2016 Clean Tech Competition, a worldwide STEM challenge for youth that held its final round and awards on the cruise. In addition to presenting their innovations aboard the ship, Clean Tech competitors also explained their projects to local fifth graders in Puerto Plata, DR, near Carnival's resort compound.

The Clean Tech group was among 500 passengers who chose to do good as they traveled. On the cruise, guests enjoyed poolside activities, but they also spent each day in the community lending a hand. Passengers could choose from several excursions, and Wicks chose to go to schools and into a local home to teach English, where in exchange the residents taught her Spanish.

"I was so transformed," Wicks says. "They taught me how to be

Not only because the name refers to the depths of the ocean. But also because Marie Wicks '86 says she could not have fathomed how the cruise would change her life.

It wasn't just any cruise. Fathom, a Carnival Cruise Line brand, specializes in voluntourism—trips where travelers

radiant, resilient, and full of faith for better days." She says the Fathom programs are different since they provide opportunities to augment the monetary donations that are the lifeblood of charities by instead offering hands-on assistance. "While donations, in general, are important, Fathom's programs provide an outlet for people to place greater emphasis and value on human interaction

and connectivity by working alongside them and helping them reach their goals. I never expected anything like that.

"I walked away nourishing my soul as much as enjoying a vacation."

She was so moved that as the ship was docking in Miami a week later, she texted her husband, Jack Wicks '86: "Puerto Plata stole my heart." She convinced him that the experience was so worthwhile that they should scrap their plans to vacation in Cape Cod and take an impact cruise instead. He agreed. So she flew back to Long Island, washed her clothes, stashed her sea legs, and repacked. The following weekend, they boarded the *MV Adonia*, bound for Puerto Plata (on alternating weeks, the *Adonia* and the *Fathom* program sailed to Havana, Cuba, for a cultural exchange program).

This time, Marie, with Jack by her side, joined 24 other passengers in mixing and pouring concrete for a one-room home to replace its 25-year-old dirt floor. As she and Jack passed concrete in a bucket brigade from wheelbarrow to house, she had a revelation.

"I had flashes of the Marist Brothers rolling up their sleeves, pouring concrete, and building the campus from nothing. It made me very proud to be part of the heritage that the Marist Brothers left us."

Marie was so inspired by the cruises that afterwards she offered to volunteer for *Fathom*. The cruise line asked her to help launch a group in New York City that would mobilize volunteers to support like-minded projects and organizations throughout the city and participate in impact cruises in the Caribbean.

"The purpose is to bring together a community of people who are action-oriented to make a difference for the common good," Marie says.

Marie's experience at Marist as past president of the Alumni Association made her well-suited to volunteer with *Fathom*. Additionally, she is actively involved with Marist on the Greystone Board (made up of former Alumni Executive Board presidents) and as a member of the Marist Alumni Recruiting Team (MART) and has previously served as president of the Long Island alumni chapter. Marie and Jack have another Marist connection as well: their daughter, Kathleen, is a 2014 Marist alumna. Kathleen earned her MA in international

relations, concentrating in international development, from American University in December and is employed by the International Rescue Committee, a global humanitarian aid and development organization.

Fathom soon asked Marie to share her story of how transformational the impact travel experience was. The company featured her and two other cruise passengers in a promotional video it released this past September as part of Carnival and *Fathom's* sponsorship of the launch of LightWorkers Media, a division of MGM Television and Digital. LightWorkers Media was founded by actress and producer Roma Downey and her husband, Mark Burnett, president of MGM Television Group and Digital.

Marie is passionate about volunteering because of her father. "My dad was a role model for me. He was an immigrant who came to

America and worked incredibly hard. He was a college graduate with a degree in political science, but he took on humble positions to save enough money to bring his wife and two kids to America to start a new life with opportunities. Yet he found time to create a civic organization that supported an orphanage back in the Philippines that paid for surgeries for people who couldn't afford them. I grew up seeing this man channeling his frustrations, because he really had high aspirations for his career, into making a difference and bringing light into other people's lives."

Then she went to Marist, an environment "which highly valued service, which encouraged it, which developed it," she says. "The heritage of service and fearlessness, bold labor and hard work from our founders has always quietly resonated with me. And when I experienced *Fathom*, it was the perfect fit: By being involved in *Fathom*, I personally

feel I'm honoring the Marist heritage and our founders."

Subsequently, Marie's passion and enthusiasm convinced fellow Marist alumni to go on a *Fathom* impact cruise. In March 2017, Michael Johnson and Brittany MacLeod, both Class of '13, and their Australian friend Elisa Iakymyn participated in several impact shore excursions, one of which was teaching conversational English to a group of students ranging in ages from 18 to 35.

In January, Marie and Jack, Michael Johnson and his parents, and Grace Camporeale '13 supported *Fathom's* impact efforts with a special Cruise for the Caribbean, sailing aboard the *Crown Princess*. Along with their *Fathom* cohort of 100 other participants, they helped with hurricane relief aid on four islands, including a rebuilding project in a small Puerto Plata hamlet struggling after the storms.

"That one tiny little pebble you think won't matter? Marie says. "It can make a big ripple!"



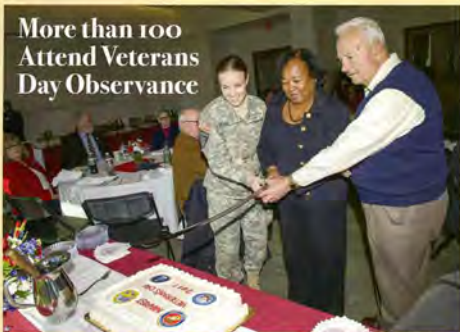

DR. CASIMIR NORKELIUNAS, associate professor of Russian and German and Heritage Professor, passed away at his home in Naples, FL, on Jan. 21, 2018. He was 80.

Casimir was a memorable teacher who inspired a love of Russian literature and culture among his students. He enjoyed leading student tours to the former Soviet Union, where from 1969 to 1997 he took more than a thousand students. Remembering Larry Sullivan '54

PROFESSOR LAURENCE J. SULLIVAN, professor emeritus of religious studies and Heritage Professor, died on Aug. 8, 2017, in Williamsburg, VA. He was 83.

A Marist Brother for 24 years, he helped construct several campus buildings including Our Lady Seat of Wisdom Chapel, the former gymnasium and auditorium that is now Marian Hall, and Donnelly Hall.

But it was his role as a professor and counselor that made the greatest impression on students. One of his courses, Marriage and the Family, was one of the most sought-after courses on campus. In 1979 he received a plaque from the graduating class honoring him as an outstanding educator. He was instrumental in initiating the counseling program at Marist and counseled hundreds of students over the years.

Born on March 22, 1932, in Manhattan, he attended St. Joseph's School in Astoria, Queens,

and St. Agnes High School in Manhattan. After joining the Marist Brothers, he received a BA from the College in 1954. He taught at St. Helena High School in the Bronx, NY, from 1953 to 1965. He completed a master's degree at the Catholic University of America and, after spending a year in religious study in Rome, earned a master's in pastoral counseling from Iona College and the CAC professional designation from the State University of New York.

Larry joined the Marist College faculty in 1967 as a co-director of the student Brothers and part-time teacher. He moved to full-time teaching as an assistant professor of religious studies in 1969. He retired from full-time teaching in 1999 but continued to teach part-time for several years.

Remembering Bro. Thomas Delaney, FMS '59

Brother Tom was a Marist Brother for 62 years. He also taught for 16 summers in Dublin, Ireland, at the Marist Brothers International Language School.

In addition to his Marist College degree, he earned an MA from Seton Hall University and attended the University of Madrid in Spain and the Spanish Institute at the University of Puerto Rico.

From 1989 to 2002, he taught Spanish at the College and

was a mentor to freshmen, living and working among them in Leo Hall.

In retirement, he taught Spanish and English as a volunteer for the Little Sisters of the Poor congregation in Queens Village, NY.

Throughout his life, he was a wonderful source of support for students and an outspoken advocate for people in need. Through the generosity of a friend who wished to remain anonymous, the Bro. Thomas E. Delaney, FMS Scholarship was established at Marist in 1998 to honor the special role Brother Tom played in the life of the College.

Brother Tom was predeceased by his parents, Thomas and Beatrice O'Hara Delaney, and his sister Maureen. He is survived by his niece, Eileen; his nephews, PJ and John; and his cousins. ☐

Alumni, Coaches Launch Marist Hockey Hall of Fame

ON JAN. 20, 2018, the Marist hockey program inducted its first Hall of Fame class: Jim McDonald '84 (posthumously), Robert Trabulsi '85, Timothy Graham '86, Kevin Walsh '91/'93MFA, and Brad Kamp '95. The award for Jim McDonald was accepted by his cousin, Brendan McDonald '91, who traveled from Colorado to accept the award on Jim's behalf.

The inception of the Hall of Fame was driven by a dedicated group of former players and volunteers: head coach Mike Beck, former head coach Rob Simmons, chairman of the selection committee and assistant coach Dr. Brian Pecchia '08, vice chairman of the selection committee Casey Bryant '17, current assistant coaches Nick Longo and Randy Hurlbert, and Rob DeLuca '11, Matt McNamara '12, and Nick Rudzwick '18.

The group spent countless hours reading through *The Circle* archives, watching game footage, and gathering statistics. The Red Foxes began playing hockey in the fall of 1979 as part of a local men's league. It wasn't until 1981 that Marist joined the American Collegiate Hockey Association (ACHA) by entering the Metropolitan Collegiate Hockey Conference (MCHC). As the 40th anniversary of the program approaches, the group felt the timing was perfect to begin honoring alumni for their accomplishments and dedication.

Jim McDonald amassed 173 points in just three seasons of intercollegiate play. His 40-goal season is second best in school history and 14th best in MCHC history. He also had the 20th best season in MCHC history with 37 goals. Sadly, he passed away in 2015 at the age of 53, leaving a void in the lives of his family, his friends, his teammates, and the Marist community.

As a freshman, Rob Trabulsi scored the first goal (as well as the second!) of Marist's intercollegiate play in 1981. He finished his Marist career with 80 goals and 82 assists. During his senior season Trabulsi became the captain of the Red Foxes and ultimately graduated as the second-leading scorer in school history. To this day he remains in the top five. Teammates praised

his leadership on and off the ice as well as his stellar two-way play.

Tim Graham ranks as one of the most prolific goal scorers in school history, tallying 95 career regular-season goals. His 36-goal season in 1985-86 made him the second-best goal scorer in the MCHC that season and is to this day the 25th best season in the 50-year history of the league. Upon graduating from Marist, Graham served in the U.S. Air Force. He and his wife, Laura, traveled from Tennessee to participate in

the Hockey Alumni Day activities.

Kevin Walsh anchored the Marist defense for four seasons and was named to three All-Star teams. He rose from assistant captain to captain, and after graduation from assistant coach to head coach. As assistant coach, he helped the team win the 1991-92 MCHC Championship and as head coach led them to victory in the 1995-96 MCHC Championship. That year the team made it all the way to the National Final Four, playing eventual champion Western Michigan in the closest game they played all tournament. Walsh resigned as coach in 1996 to join the U.S. Secret Service, having lifted Marist to the third-ranked team in the country. Walsh traveled from Georgia to receive his award on Hockey Alumni Day.

Brad Kamp became Marist's starting goaltender as a freshman and backstopped the Red Foxes to an MCHC Championship his first year. His .930 save percentage in 1993-94 is tied for the best single-season mark as a starter in school history and earned him the MCHC MVP that year. Kamp also won Divisional Outstanding Goalie twice and was a three-time MCHC All-Star. No other goaltender in Marist history has three seasons with a goals-against average under 3.55, and his 41 career wins are the most in school history.

Prior to the Hall of Fame induction, more than 40 graduates participated in an alumni game at the McCann Ice Rink in Poughkeepsie. ❧

Turning a Lifestyle into a Brand

RYAN ORABONE '06 grew up skiing and has always had a passion for it. He loved the close-family atmosphere that he found up on the mountain, how everyone is happy, how nobody fights.

"I see it said in sports all the time," says Orabone, "players saying 'my teammates are my family.' But we have family on the ski mountain that is truly a second family." Orabone ultimately turned his obsession with skiing into a livelihood: he founded a ski apparel company called Till I Die.

After graduating from Marist with a double major in marketing and international business, he became an assistant buyer for Macy's and worked his way up in the company. After three and a half years, he left Macy's and went on the road with friend Paul Vikan to sell his first T-shirt designs.

They were "awful," he says. The effort failed and he spent all his money. He decided to learn all he could about the apparel industry in order to start his own company. "It was dead-set on making this happen."

He went to work for clothing companies Greg Norman, True Religion jeans, and Ben Sherman, gaining exposure to every side of the business.

In 2010 Orabone started his company, calling it Ski Till I Die. Then, he says, "we realized that people have the same passion for whatever they do that we have for skiing." So he dropped the word "ski." The idea was still "Whatever you do, do it forever. Do it till you die."

As for a logo, he wanted something that could be easily recognized. He chose a shield with two diamonds, reflecting the double-diamond ski trail sign that indicates an expert-only trail.

His goal is to make Till I Die a national iconic brand. He wants people to see the logo and think the brand is active and fun.

Orabone still goes on the road, this time with more success. Each week he drives about 500 miles for buyers' meetings and on-site events, circling from his home in Killington, VT, to New York City and Rhode Island, where

his supplier is located. The apparel is started in Honduras and finished in America. Next year, products will originate in India. Although currently he is the only full-time staffer, he has help from four others including Scott Kaufman '06 who handles marketing and public relations. He plans to hire an associate and two interns this summer.

Currently on-site events such as pop-up shops at ski resorts being in 50 percent of his business. Events also include fundraisers for Vermont Adaptive Ski and Sports and Carve for Cancer.

The Till I Die customer base is split evenly between men and women. They are ages 25–34 and live mainly in the Northeast. Web sales being in 25 percent, as do sales in 30 stores that carry Till I Die apparel.

This past February, Orabone returned to the Marist campus to speak to students in the College's Fashion Program about starting a fashion brand. He offered some tips.

"It's really important when you start your own company to know what you know and know what you don't know." For example, he let others create the company web site since web design wasn't in his skill set.

"It's OK to make mistakes." His first decals weren't waterproof, he said. He cited a second example: a T-shirt he was determined to sell in an orange hue.

"People just don't like tangerine." The same shirt in mint green sold out four times.

"Pair what you know with what you love." He knew skiing, and he knew how to plan, he says.

The future of Till I Die is looking good. This summer his apparel will be in surf shops for the first time. His products will be in 75 ski shops next season. His items will be in all 50 states by 2012. In 2013 he will start selling in Canada.

He's thinking of branching out into fishing and boating apparel.

"I love doing this. Every single day is awesome." 📷

DR. EDWARD P. DONOHUE '55, professor of philosophy at Marist College from 1969 to 2004 and Heritage Professor, died Dec. 6, 2017, in Poughkeepsie. He was 85.

Born on Nov. 10, 1932, in Queens, N.Y., Edward left home at a young age to become a Marist Brother. He traveled the world teaching and serving others as a Brother in his early years.

As a Brother, he also helped build the original buildings on the Marist College campus. He was a carpenter on the chapel, a ditch-digger on Donnelly Hall, a roofer on Adrian Hall (now demolished),

and an assistant electrician on the old Fontaine Hall and Library (where the Cannavino Library now stands).

He earned a BA in French from Marist College, an MA in philosophy from Fordham University, and a PhD in philosophy from the Catholic University of America.

He chaired the Department of Philosophy from 1979 to 1981 and chaired the Division of Humanities from 1981 to 1984.

He married the love of his life, the former Nancy O'Brien, on Dec. 28, 1974. His greatest joy and love was his family. He often said that being a father was the most cherished part of his life.

Ed enjoyed playing the piano, attending Broadway shows, visiting museums, and studying art. He liked watching his favorite teams: the New York Yankees, Giants, and Knicks. Golf was also a pastime in his earlier years. He had a thirst for travel and enjoyed cruising with his wife, taking almost 30 cruises after retirement.

South America Sojourn: Q&A with Cara Mooney '15

CARA MOONEY '15 has been doing a little bit of traveling, to say the least. In 2013–14 she studied in Spain for 14 months, living with a host family and studying at the Universidad Carlos III de Madrid. She also worked and interned at the U.S. Embassy in Madrid, as well as taking the time to travel to Belgium, France, Austria, Hungary, and Morocco. After graduating from Mariet she spent two years teaching English in South Korea on a Fulbright grant. She has also visited Japan, Taiwan, Myanmar, Thailand, Vietnam, Fiji, New Zealand, Ireland, Portugal, Bermuda, the British Virgin Islands, Canada, Costa Rica, Belize, and Guatemala. A photographer, she has documented her trips in photos and text at caramooneyphoto.com.

On her blog she wrote that not long before she was accepted to the Fulbright program, she was diagnosed, at age 21, with rheumatoid arthritis (RA). The painful condition made difficult even basic tasks such as getting dressed. She forged ahead, setting up multiple daily medications, pharmacies, and health insurance for her South Korea stay, and continues to travel.

Recently she spent three months backpacking in South America. *Mariet* magazine asked her about the journey.

What countries did you visit?

I traveled for just over three months. I started in Colombia and followed the Andes south to Peru, Bolivia, and then into the Patagonia region of Chile and Argentina.

Why did you want to go there?

I have never traveled in South America so it has been a continent I have wanted to visit for a long time. I'm fascinated by the rich culture and history and I love the outdoors. I've seen few places with such diverse and awe-inspiring geography. Even after three months, I feel as though I only brushed the surface, but you have to pick and choose. After spending over two years in South Korea, I also wanted an opportunity to brush up on my Spanish.

Did you travel alone?

I planned this trip with a friend I made from Fulbright Korea. We traveled two months together and I did one month alone, where I traveled primarily in Bolivia.

What was the most challenging thing about visiting South America?

You hear all these stereotypes about going to Latin American countries, traveling solo or traveling as a young woman and how dangerous

it is, and while there are risks, there are ways to still be adventurous and travel smartly. I spent over seven weeks trekking and camping through Patagonia, largely unguided. It was a huge mental game and the preparation was extensive.

What was your favorite moment?

I hadn't planned on doing any extreme mountaineering, but that's the exciting side of spontaneous traveling. While in Bolivia, I heard there was a "beginner" mountain for anyone who wanted to attempt a 6,000-meter climb. Part of the Cordillera Real, Mount Huayna Potosí is just over 6,058 meters (19,874 feet in elevation). It was a three-day climb with an overnight ascent to reach the summit before sunrise. It was the most physically difficult thing I have ever done. I almost passed out twice from exhaustion and lack of oxygen, but in that moment, standing at the peak watching the sunrise was worth the suffering.

What is one item you can't travel without and why?

Looking past the obvious like passport and cell phone, I can't travel without my nice DSLR camera. Often, to drop precious pounds of weight from their bags, travelers go without and only use their cellphones. While the camera qual-

ity is increasing with each new generation of smartphone, it still can't replicate the quality of a DSLR. Even though they're expensive and heavy, I have lagged them through cities and up mountains to get the perfect shot.

What was your favorite city in South America that you visited and why?

Medellin in Colombia was one of my favorite cities I visited, with Arequipa in Peru being a close second. Out of all the countries I told people I was visiting, Colombia, and Medellin in particular, was the one people told me to worry about the most because of its violent reputation. The city turned this notion on its head. I have not met a more gracious and friendly people, so proud of how their communities have continued to improve. They have come a long way from the days of Pablo Escobar.

What was the most fun thing you did?

While perhaps this wasn't the most fun, it was definitely the most memorable. Towards the end of our trip, near Ushuaia (commonly called the southernmost city in the world), we visited Isla Magdalena to see the Magellanic Penguin Colony. The island is four hours away round trip from the city port Punta Arenas. Our ferry ended up getting stranded on the island by the receding tide and the rescuing boat failed to tow our ferry off the rocks. What was supposed to be an idyllic five-hour tour to see some penguins ended up being over 12 hours starving on a stranded boat.

Where did you stay?

I stayed in a few hostels while in the city as well as with a few friends. Otherwise it was camping.


Can you talk a little about your Fulbright experience?

Where to begin? I did a Fulbright grant for two years in South Korea as an ETA or English Teaching Assistant. I was a full-time foreign English teacher at a middle school in Gwangju, a large city in the southwest of Korea. I taught over 800 students a week. While working, I also worked a number of Fulbright initiatives and programs including the program for North Korean Defectors, where I was the regional coordinator, and Korea Bridge Initiative, which provides weekend classes by volunteer teachers to students who are unable to afford to attend hagwons (cram schools).

What is your attitude regarding traveling with RA, especially with all the physically demanding activities you do such as hiking and ice-climbing?

I'm still learning how to live my life the best I can with RA. It has its challenges. I'm currently in a sort of remission, so I'm fortunate enough to be able to lead a normal life for the most part. Some days are tougher than others. I like pushing myself physically and mentally. Just because you have a disease doesn't mean you can't try to do what you enjoy. I like climbing and hiking because there are days when I can't physically do it, so when I have the opportunity, I take it. There's no feeling quite like reaching the summit and knowing that you got yourself there. I think more people could live like that.

What's next for you?

Now that I'm finally back in the USA, I plan to work in New York City and perhaps plan my next adventure.  —Eros Rios-Timoco '20

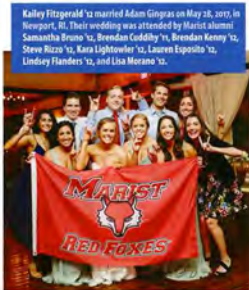

A “Guardian Angel” for Students in Need

Dave Donoghue '64 established a number of scholarships: one to assist students with disabilities; one to honor an influential professor; and one to support aspiring social workers. He also went above and beyond by anonymously supplementing aid to Marist seniors close to dropping out because of sudden financial hardship. Helping others seemed to be in his DNA and was also informed by his life experience and career choice.

BRING DERMED AN ANGEL. It is the kind of talk Dave Donoghue's humble disposition and Irish wit would have put a quick end to. But an angel among us is what Donoghue, a member of the Class of 1964, was to dozens of Marist students who needed financial help to complete their college education.

For a number of years, in addition to establishing several scholarship funds, the Marist alumnus went the extra mile for students encountering sudden financial hardship. Reaching out to others just seemed to be in Dave Donoghue's DNA. That and a strong faith informed his optimistic perspective of a glass half-full. His early years may also have encouraged his choice of a career in social work.

Born in Watertown, NY, he was the eighth and last son of Raymond and Mary Carroll Donoghue. His mother died when he was three and he came to live at a children's home, an orphanage, and eventually with his paternal grandmother. At age 6, he went to live with his paternal aunt and uncle, Dorothea and Thomas Shea, in Amityville, Long Island.

In time, the Donoghue family was brought back together. Dave's love for his parents and his aunt and uncle led him to establish a scholarship at Marist in their honor. The Donoghue-Shea Family Memorial Scholarship fund now assists Marist students with physical or learning disabilities.

Donoghue was employed as a childcare worker at various Catholic-affiliated children's homes in New York and Connecticut. With his father's support, he attended Marist College and found a mentor and lifelong friend

in lieu of Joseph L.R. Belanger FMS '48, professor of French. Not surprisingly, his major became French. He then earned an MSW from the University of Michigan's prestigious social work school. Donoghue honored his former professor by establishing the Ben Joseph L.R. Belanger, FMS, Scholarship endowment to aid students with unforeseen financial circumstances.

Donoghue was a licensed clinical social worker, a marriage and family therapist, and a member of the National Association of Social Workers. He was employed at

Catholic Charities/Catholic Family Services in New Britain, CT, for 31 years before retiring. Recognizing how important it is to have more male social workers, Donoghue's next scholarship focus was to help Marist students who were pursuing that goal.

Recipients were recommended by the School of Social and Behavioral Sciences in collaboration with the Office of Student Financial Services, which documented financial need. Knowing the necessity of graduate work in his field, one of Donoghue's aims was to lessen the undergraduate debt load of these Marist students.

Amid his ongoing support of scholarship funds, Donoghue asked if any Marist students currently close to graduation were on the verge of dropping out because of family financial problems. Yes, he was told, it's an important need at Marist.

Over the past decade, the alumnus helped out a number of desperate students and their parents. Recipients of the hardship scholarships were selected by Student Financial Services, and because Donoghue requested anonymity, his code name became “the guardian angel.”

Dave Donoghue endured many health challenges over the years. He drew strength from his faith, and when he passed away on Aug. 27, 2017, at age 79, his memorial card cited St. Francis of Assisi: “O Divine Master, grant that I may not so much seek to be consoled as to console; to be understood as to understand, to be loved as to love. For it is in giving that we receive.”
