Vice Presiden' Agnew came to Capitol Hill and met for an hour with House Speaker Car Albert and Republican and Democratic leaders. Mr. Agnew gave them a letter declaring his lawyers' belief that he cannot be tried by a grand jury since he's Vice President. Therefore, Agnew contends he cannot be vindicated in the courts. Since he is Vice President, Mr. Agnew is asking a select committee of the House of Representatives to conduct the investigation of charges against him. Mr. Agnew's letter was read on the floor of the House where only about fifty members were still

present right after his late afternoon meeting with House leaders. He left the Capitol telling reporters only that his letter speaks for itself and that he might have more comment in a few days.

What the Vice President asked for was investigation without impeachment proceeding. All this after Attorney General Elliot Richardson said his evidence in the Agnew investigation would be given to a Federal grand jury in Baltimore day after tomorrow. Richardson saying there'd been discussions between him and Agnew's lawyers and that they "failed to yield a satisfactory resolution."

"It has proved impossible" said the Attorney General,
"to reconcile the Vice President's interest as represented

by his council with the Justice Department's perception of

its responsibility to insure that justice is pursued fully and

fairly."

This morning the President met here for an hour and a half with Attorney General Richardson and his Assistant for the Criminal Division, Henry Peterson. Then the President called Vice President Agnew to the Oval Office for a talk. Later today Mr. Nixon issued a statement saying the Vice President had again denied charges against him and had informed the President he intended to take his case to the House of Representatives. After praise for Agnew's past four and a half years of dedication and distinction in service to his country, as the President put it, Mr. Nixon urged that the Vice President be accorded the basic, decent
