If there is a general coal strike within
the next few days, it will only mean increasingly vigorous antilabor reaction in Congress. So says Congressman hartley who cosponsored the new labor law. And then Hartley threw down the gauntlet, tonight -- a challenge to John L. Lewis. He said that if the present statute proves ineffective in handing Lewis, Congress will take immediate steps to strengthen the bill until the United wine Leader is effectively curbed.

Congressman Hartley added: "In the event that the new law may not prove sufficient to end the ever-recurring threats of coal strikes, I shall introduce a bill wixik much stronger than the one Congress has just seen fit to pass."

government operation of the soft coal mines could be the answer to the threat of a national coal strike next month. Said the New Jersey Congressman: "Such continued action on the part of the administration would constitute another in a long series of surrenders

The coal mine walkouts continue to
increase - strikes of protest against the new labor law. Today an adininistration official stated that/it looked as if the mines would be completely shut down by the time Friday rolls around -- Friday the day when the minxexuxax miners are scheduled to take a ten-day holiday.

Today the Northern and Western Coal operators gathered quietly in Washington to discuss the effect of the new law. They say they got into contact with officials of the United Mine Workers Union and made proposals to renew negotiations for a EmixaEtty contract. They got nowhere, so they say; - union officials showing no sign of wanting to renew discussions for a contract that would prevent a general soft coal strike on June Thirtieth, the date set for the government to turn the mines back to the owners. Actually on June Thirtieth, the miners will be out on that ten-day vacation, scheduled to return on July Seventh. A strike would take the form of their failure to return.

## MhRSHALL_PLAN_

(London says that Foreign secretary Ernest Bevin has definitely decided to go ahead "isth the Marshall Plan, even if Soviet Russia refuses to participate.

Soviet blasts against the Marshall Play continued today, with Pravda intimating that cooperation with the united states for aid to Europe would mean an mefigx infringement of the sovereignty of European countries.

The British are increasingly fearful
that the soviet part in negotiations will be to obstruct and that Molotov will bring about another deadlock the old familiar story.

The United Nations got the official report today on charges made by Greece against the Communist Governments of Jugoslavia, Albania and bulgaria. The answer is - yes, all three of those puppet countries have been recruiting, training and arming Red Guerrillas, and sending them into Greece to fight against the Greek Government. The sex report by the Investigating Commission declares that Jugoslavia has least one Refugee Camp devoted to the business of turning out Red Guerrillas for a Communist revolution in Greece.

Recommendations are made. The report
advises that the United Nations should keep a permanent border patrol along the frontiers of Greece and its Communist neighbors - to stop the Communist penetration of Greece. Also - put the Refugee Camps in those Communist countries under International control to stop them from being used to mobilize Red Guerrillas for Civil War in Greece.

The report is made by a majority on
U. N. - 2
the Commission. The Delegates of Soviet Russia and Puppet Poland disagree violently. They put all the blame on the Greek max Government, and charge that the recommendations in the report would be an infringement on the sovereignty of the puppet nations. These recommendations will now be taken up by the Security Council of the U.N., and face the prospect of
a sax Soviet veto.

## ADD UN

The latest: A bulletin from Lake Success. The $U N$ has ordered its Balkans' investigating Commission to cross the Bulgarian frontier, and find out at first hand if Bulgaria is aiding Greek Communists This after Bulgaria refused twice to admit the $U N$ 's commission into that country.

This action is one of the most serious, certainly the boldest, yet taken by the UN.

The Russians objected vigorously to tonight's decision at Lake Success, supported by their $x \pm$ satellite Poland.

But the other $U N$ members, obviously fed up with Russian obstructionist tactics, gave their Balkans investigating commission the green light.

WHALING

Secretary of State Marshall supports -
General Macarthur's permission to let a Japanese whaling commission go to antarctic waters. This has aroused protests from Great Britain, Australia, New Zealand and Norway. They claim that a renewal of Japanese whaling might lead to a renewal of the Japanese Navy - although it seems a little far fetched to think of a whaling vessel as a battleship. The Macarthur contention, now supported by the Secretary of State, is that the Japanese whaling expedition, by bringing back maxiex whale meat and oils, will ease the food problem in Japan, and decrease the need for American aid - lighten the burden of American taxpayers.

Here's the story of the Terrorist attempt to kidnap the British Liason Ofîicer to the United Nations Commission in Palestine. He is Alan Major, who plays an important part in the investigation the U.N. is conducting. Today, he left the security Zone in Jerusalem, which is heavily guarded, and went to his home to attend a birthday party for his daughter. I suppose kr felt safe - connected as he was with the United Nations inquiry. Anyway, Alan Major's wife is Jewish - his daughter half Jewish.

As he came to the doorway of his home,
he was suddenly attacked by three armed men, who blackjacked him and tried to chloroform him. The only thing that saved him from being kidnapped was the fact that his aaugher was on the balcony watching as her father came home. She screamed for help, and that attracted the attention of a British Armored Car which was passing. The armored car came roaring - whereupon the would -be kidnappers abandoned their attempt, jumped

into an automobile, and went speeding away - covering their escape with gunfire. The driver of the armored car was wounded in the hand. The Liason Officer to the U.N. Commission was taken to a hospital.

Meanwhile, in Tel lviv, mysterious doings were reported. Today, the U.N. Commission went to that all-Jewish city - but their Chairman had xi arrived before them, yesterday. The story is that last night he, U.N. Whir Chairman Emil Standstrome, had a secret conference with the leader of the underground Terrorist Organization. xxxi Irgun Zvai Leumi. From the account we have, the U.N. Chairman was met at midnight by two members of Irgun, who took him in a waiting taxicab and drove him to a hush-hush meeting with the mysterious leader.

This afternoon the U.N. Commission denied officially that any such held, and explained that Chairman Sandstrome had come to Tel Aviv in advance - just to get a rest.

We hear something in a matter that everybody is thinking about - industrial atomic power. When, and where? Today's word is that the first atomic power houses will be installed in locations that are short of the conventional sources of energy - places Without easy access to coal supplies and without water power.

Congressman Walt Moran of Washington wrote to the atomic Energy Commission and asked for an opinion on statements that it was useless to continue building great dams for hydroelectric power, because these would be superseded by atomic energy within ten years.

The answer to this is given by David Lilienthal, Chairman of the Atomic Energy Commission. Speaking of the coming of industrial atomic power, he states: "We believe that the process will, in general, be one of gradually supplementing - rather than replacing - other means of generating electrical power. It is very zikax likely," David Lilienthal

goes on, "That the first commercial installations for atomic power will be in locations with inadequate access to coal and economical water power.".

The tone of this reply is interesting -
seeming to take for granted that atomic power for industrial use is definitely on its way.
