GOOD EVENING EVERYBODY:

Secretary of State John Foster Dulles held a news conference today - at which he game some further comment on the Geneva Conference. This following - President Eisenhower's television-radio report, last evening. Secretary Dulles used the word - "brittle;" saying - that the Geneva talks have made American-Soviet relations "less brittle."...

The way things were, previously, - it was always possible to start a war, merely in the course of Diplomatic negotiations. Secretary Dulles thought - this danger had not, really, been very great; but it did exist. Negotiations tricky, when relations were so "brittle."...All of which goes back to some very simple human ways and habits. Two characters - in such a state of suppressed anger that, even when they talk things over, trying to settle the quarrel - they may

get into a fight. It sure helps - when they cool off enough to hold a reasonable discussion, without the danger of hostilities breaking out...

This is the reasoning behind a Dulles declaration, today, that - as a result of the Geneva Conference, the danger of war has receded. The two sides, at least, can talk things over - without a danger of coming to blows...

Secretary Dulles also discussed the forthcoming talks with Red China - beginning at Geneva, on Monday.

Yesterday we heard - it would be a meeting at the level of the foreign ministers...But now the word is - that ambassadors will meet, the ambassadorial level...

Yesterday, the State Department said - the meeting next week would confine itself to the subject of American prisoners held by the Chinese Reds.

Secretary Dulles, today, indicated - that the scope of

try to find out if there is any possibility of arrang
ing for a cease fire in the Formosa straits...

Back in April, the Secretary of State was cool and reserved - in talking about the chances of a conference, with the Chinese Reds. He didn't think so much of it then. But now, as he points out, several things have happened ... For instance the Reds did set free some American prisoners - fo r airmen, whom they had convicted of espionage. Also - they stopped a lot of their war-like gestures against the Chinese Nationalists, in the Formosa sector. Moreover, they eased up in their vicious Anti-American propaganda - taking a less hostile tone...

The result was - a change of mind on our side.

Today, Secretary Dulles revealed that - on July Eleventh, the State Department proposed negotiations, direct talks, with Red China. Which resulted quickly in arrangements - for the ambassadorial conference, next week.

CORDELL HULL

The stately Episcopal Cathedral, in Washington, was crowded with a distinguished throng, today. Two thousand people - including high-ranking officials of government - and diplomats representing fifty countries. Attending - the funeral of former Secretary of State Gordell Hull. Who died over the weekend - at the age of eighty-three. Cordell Hull - who was our Secretary cf State, in the administrations of Franklin D. Roosevelt.

CITIZEN

An American ambassador - trying to help an American citizen in prison. Sounds like some place behind the Iron Curtain - but it's London...

William John Hurst, called a Harvard student, is being held in Brixton Prison. "Under the Alien Act," say British officials. The U.S. Embassy thinks this means - illegal entry. Anyway, Hurst called the Embassy asking for help. So an Embassy official will go to Brixton Prison, tomorrow, to see what it's all about.

President Eisenhower's road-building program went rolling through the House of Representatives today.

This - in spite of the objection by Congressman "oward
Smith of Virginia.

Chairman of the Rules Committee - a Democrat in a key position, Congressman Smith urged the house - to put off the measure until next year. Saying - the law-makers could not give sufficient attention to the multi-billion-dollar program for highway construction. Congress - in a rush to adjourn for a vacation. "We're all in a state of confusion, " Congressman Smith argued. But he argued in vain. Congress voting to take up the giant road-building measure at once. The vote - 274 to 128. So now they'll go ahead with it - in the rush and confusion.

RESERVES

Congressional action has been completed on President Eisenhower's sweeping military reserve plan. Requiring - compulsory reserve training of youths.

A joint committee of the House and Senate agreed on a final version of the bill - which the Senate promptly okayed.

A Senate Investigating Subcommittee is hearing testimony - from Air Force Secretary Harold Talbott.

Whose business affairs are the subject of the inquiry.

The Secretary of the Air Force - a partner in an engineering firm. Which - has been doing business, and seeking business, with conerns that have defense contracts...

The Subcommittee has likewise called representatives of the Douglas Aircraft Corporation. Which, of course, does a huge lot of war plane construction for the Air Force. All this follows evidence, today, given by John A. Johnson, general counsel for the Air Force. Who told the Subcommittee that the private business firm, with which Secretary Talbott is connected - sought a contract with RCA, which does a gax huge lot of defense work.

Johnson says - the matter was taken up with

Attorney-General Brownell - who was informed of the proposed business deal. The verdict was - that there was nothing illegal about the transaction. But Brownell advised that it be held up. So the whole thing was delayed - and, eventually, nothing came of the proposition. Delay - and then no action..

Air Force Secretary Talbott has received a hundred and thrity-two thousand dollars in profits from the firm in which he is a partner. That much - during the time since he became Secretary of the Air Force.

This afternoon, Air Secretary Talbott appeared before the Subcommittee, and said he had "a statement" to make. But he postponed making rhe statement - until tomorrow.

The Subcommittee recessed - after summoning aircraft makers Donald Douglas, Senior and Junior, to

There's a report that President Eisenhower will make a statement, regarding the Talbott Affair, at his weekly news conference tomorrow.

The Upper Colorado - Echo - Dinosaur Project will go over to the next session of Congress. Today,
