Senator Knowland of California - sounds a warning note. Today, he took himself out of the campaign. Which he had entered, tentatively, if President Eisenhower declared himself out. Sen. Knowland referred back to the surprise victory of President

Truman in Nineteen Forty-Eight, and warned - against Republican over-confidence. "Don't think it's a push-over," said he. He called for a united Party, and said - the

Republican Conservatives don't think they 've tea been treated any too well by the Eisenhower administration. It is important," said he, "to bring in people who supported the late Senator Taft. So they will feel - they人re part of the party, and part of the campaign.

Attention focuses on Vice-President Nixon. Will he be retained in second place on the ticket? Today, Republican Chairman Hall said - he was quite sure Nixon would be the choice for the vice-presidential nomination. But he conceded: "We hear of opposition to him."

One line the opposition takes - is that Nixon has a
faculty for creating antagonisms. His opponents point out that, yesterday, President Eisenhower did not endorse him. Friends of the Vice-president cite - the warm terms of admiration, in which the President spoke of Nixon.

The House today passed the Upper Colorado River Bill as advocated by President Eisenhower. The measure - for a seven hundred and fifty-six million dollar water and power development in four Western states. There was angry opposition, but the controversial bill was passed by the House - two -hundred-and-fifty-six to one-hundred and-thirty-six.

The University of Alabama, today - expelled

Autherine Lucy. Which comes as a surprise move - following the court order yesterday. Requiring the University - to re-admit the Negro co-ed.

The college officials act on the ground - that

Autherine Lucy made "outrageous and unfounded charges of misconduct"against the university officials. When she claimed that those officials had incited the rioting, which attended her entrance into the university. She said the mob violence was a "cunning strategy" to keep her out. So now the university authorities declare - that no student could be permitted to remain, after making such accusations against the university.

Hence - expulsion.

All this - in the face of the court order, requiring

Autherine Lucy to be admitted to classes, Monday morning.

Today, the federal judge who issued the order said - he can't do
anything about the expulsion. Unless - the Negro co-ed goes to court again.
 down in Alabama - a puzzle.

The University of Kentucky announces - the breaking up
of a campus mob of gangster students. Four students - arrested.

A whole series of crimes alleged - from robbery to dope.

The case was broken by an F.B.I. man, who enrolled
in the college as an undergraduate - and got into the gang.

Students of the mob told him: "We came kre here to learn how to become big-time gangsters." Which hardly sounds like higher education.

The campus gang is accused of thirty-one thefts in the college, burglaries in downtown Lexington, bomb explosions in dormitories. And - the sale and distribution of marijuana.

Young thugs going to college. Because being a
student - was an advantage in a career of crime. College
life - and the higher education.

## BALLOONS

Washington makes a reply to Moscow, and virtually uses that old expression - you're another. On the subject of those weather balloons. The Soviets complained - because American gas bags with scientific instruments have been drifting over to Russian territory. Our answer is that, at the very moment Moscow was making the protest - Soviet weather balloons were drifting over other nations, including American territory.
At the State Department, Spokesman Lincoln White
informed the news reporters - that Soviet balloons crossed over into Alaska. Though, seemingly, none had reached - the United States proper.

## President Eisenhower and Italian President

Gronchi issued a joint statement, this afternoon, declaring - that their two countries intend to strengthen the North Atlantic Treaty Alliance in every way they can. They'll try for dis-armament arrangements, but warn - there must be no relaxation of Western defenses.

In their joint statement, the American and
Italian Presidents agree - that Italy no longer needs
U. S. economic aid but would like - long-tera
investments by American business.

The two Chiefs of State had their second meeting today.

TheWestern Allies, today, demanded - that West Germany continue paying for the support of Allied soldiers. Until West German rearmament has progressed further.

Under present agreement, the Bonn government will pay seven-hundred-and-fifty million dollars for the support of half a million troops - covering the year ending Mey Fifth. Finance Minister Fritz Schaeffer declares - they'll pay no more, after that.

But the British, French and Americans argue - that, right now, West Germany is not providing a proper number of German troops for the army of the North Atlantic Treaty Alliance. Sc, therefore, the Germans/ should pay for Western soldiers defending its own territory.

ATOMIC.
New hydrogen bomb tests in the Pacific - to begin shortay after April twentieth. Today, the Atomic Energy Commission issued a warning - that an area of more than $t$ four hundred twenty thousand square miles around the Marshal Islands will be a "danger area." Effective - April twentieth.

Meanwhile, there was a new outbreak of gunfire along the Gaza Strip. Israelies and Egyptians - in a five-and-a-half hour shooting match. Not much damage done - apparently.

The revolution in Brazil ended, officially, today. That "vest pocket" insurrection, staged by several Air Force officers in the jungle. Yesterday, federal soldiers captured one. Today, the other two - were in Bolivia. Having escaped as government soldiers occupied air bases in the jungle.
