LABOR

THE LABOR PEACE PARLEY BEGAN TODAY IN FORMAL AND STATELY FASHION. THE PLACE OF MEETING -- THE WHITE HOUSE, WITH THE PRESIDENT OF THE UNITED STATES PRESIDING. SECRETARY OF LABOR MISS FRANCES PERKINS PARTICIPATED, AS THE COMMITTEES OF THE A F OF L AND C I O WENT INTO SESSION IN AN ATTEMPT TO END THE THREE YEAR CIVIL WAR IN THE RANKS OF LABOR. THE PRESIDENT BEGAN THE PROCEEDINGS BY SAYING HE HAD A PREMISE. AS HE PRAISED IT -- "A PREMISE THAT BOTH SIDES WANT PEACE. THAT MEANS OF COURSE, " HE CONTINUED, "THAT BOTH SIDES GO INTO CONFERENCE WITH THE IDEA OF CIVING ASSWELL AS GIVING A THIS FOLLOWED BY PROMPT ACTION, WHEN THE C I O PRESENTED A PLAN--A PLAN TO FORM "AN AMERICAN CONGRESS OF LABOR." THIS TO BE A UNIFIED ORGANIZATION REPRESENTING THE A F OF L. THE C I O AND THE RAILROAD BROTHERHOODS. NEITHER, A F OF L PRESIDENT WILLIAM GREEN NOR C I O PRESIDENT JOHN LEWIS TO BE ELIGIBLE FOR ANY OFFICE IN THAT CONGRESS OF LABOR.

SUCH WAS THE PLAN SO PROMPTLY SUGGESTED BY THE C I O. AND IT WAS

JUST AS PROMPTLY REJECTED BY THE & F OF L. THE FEDERATION COMMITTEE

THE ELLIOTT ROOSEVELT IDEA IS THAT THE LICENSES SHOULD BE PERMANENT -- A STATION SHOULD BE GRANTED ITS WAVE LENGTH NOT FOR ANY SHORT TERM, BUT PERMANENTLY. and, by the way Elliott Roosevelt is not stopp at the White House with his mother Father. He's at the New Willard wit mine host Havy Surpriselle.

Probably because he is here on business - trying to avoid any political or parental complications. The Administration is pressing for a vote on the three hundred and fifty-eight million dollar bill that would authorize six thousand war planes for the army. In the course of the debate today, Administration leader Senator Barkley had something to say about the United States Neutrality Law — the Senator has his doubts. And he demanded quick action to provide the three hundred and fifty-eight million for the six thousand planes program.

"It is doubtful," said he, "whether the Neutrality

Act, whether enforced or not, has contributed to the peace of the

world."
