Fri. June 2 - 1950.

Over in Tokyo Saturday morning has already begun -- the day set for the Communist general strike. The Tokyo dispatch states that forces of Japanese police are mobilized to check the Red demonstration -- a protest against the trial of members of a Japanese mob that attacked American military ~~men~~ men on Memorial day.

The latest from Hawaii shows that Mauna Loa is right now, staging its most melodramatic spectable - in the history of living man. Actually, that fabulous fire mountain is putting on two big shows. - (the second almost as terrifying and awe-inspiring as the first.)

Circus number one - the giant eruption last night, when Mauna Loa suddenly blew its top. The explosion turned the night into day, an infernal day of roaring violence and glaring light. A column of fire soared high into the sky, with a red brilliance that could be seen in Honolulu - two hundred miles away.

They say the towering mass of smoke and flame shot four miles into the air, twenty thousand feet.

An ocean of molten lava poured out of the crater, and went streaming down one side of the volcano, and the rolling river of fire is described as shooting flame twenty feet into the air, all along its length. So, moving on for miles, it was a stream both of incandescent rock and leaping flame.

Mauna Loa is on the Island of Hawaii, the

The river of molten stone went streaming down
the slope to the shore, fifteen miles away, and that
provided - circus number two: - When the lava plunged

AMERASIA

The State Department confirms a rather startling story in the Amerasia case. It is true that a cablegram was sent to the American Ambassador to China in Nineteen Forty Four - presenting suggestions advanced by that left wing magazine. It has been charged repeatedly that Amerasia was under Communist influence, and the proposal was that American aid be given to the Chinese Communists fighting the Japanese.

(The cable was marked - "Hull to Chungking."

However, there is no indication that the message was signed or even seen, by former Secretary of State Cordell Hull. ~~All such cables from the State Department are signed with the name of the Secretary of State. That's automatic routine - whether the Secretary of State knows about the message or not.~~

It is explained that the cable in question contained a digest of material printed in Amerasia - the custom being to send such magazine summaries to American diplomatic representatives abroad. The leftist magazine argued that the United States should back the Chinese

Reds, and give them support. The cable put the proposal in these words - "Establishing a close working relationship with the guerrilla Communist forces now operating behind the Japanese line, and to bolster the activities with material and financial aid."

Another Amerasia inspiration sent along to the American ambassador at Chungking, was a suggestion that this country should back a leader for Japan- a Japanese named Susomo Okano. The idea was for the United States to back him as the "Tito of Japan." That's the Amerasia phrase - "Tito of Japan." Well, at that time, Nineteen Forty Four, Tito was the pride and joy of the Soviets, as he led Yugoslav Communist resistance against the Nazis.

Since then, of course, Red Marshal Tito has become a rebellious puppet - in bitter feud with Stalin. (But, in those days, the proposal that the United States should back a "Tito of Japan" had a very different look.)

The State Department cablegram, sending all this Amerasia material, ~~was found~~ seized in the F.B.I. raid on the

magazine offices. The documents were stolen from the State Department, and this one must have been of lively interest to the editors of Amerasia - seeing that their view on Far Eastern policy had been sent to the American Ambassador at Chungking.

MCCARTHY

Senator McCarthy offers to get from under that - "Congressional immunity." But, there's an - if.

The Senator has been hurling his barrages of sensation - in such fashion that he cannot be sued for libel. (It's a principle of government that the members of national legislature shall be privileged to express themselves freely, in Congressional proceedings without danger of being taken to law about it. That is an old safeguard, intended to protect freedom of legislative debate - against any and all authority.)

But the charge is widespread that Senator McCarthy has been using Congressional immunity as a shield for irresponsible accusations - and this was decried in the statement issued yesterday by seven Republican senators headed by ^{Sen.} Margaret Chase Smith of Maine.)

So now, ~~the~~ Senator ^{McCarthy} says he will discard his Congressional privilege, and make his charges out in public, outside of Congress - where he can be sued for libel. ~~Understand~~. The condition he makes is

that President Truman shall open those loyalty files - not merely the State Department records which the Senate Committee has already been allowed to see, but also the reports of the F.B.I. [What are called - the "raw" files.

The immediate response in Washington is - that President Truman is not likely to take ~~up~~ McCarthy up on this. He won't open the confidential F.B.I. files - a thing so vigorously opposed by F.B.I. chief J. Edgar Hoover. (So the best belief is that not much will come out of today's McCarthy offer to get out from under the Congressional immunity - if.)

OAK RIDGE

At Oak Ridge, Tennessee, the atomic scientists are poking fun at a warning printed in the British Medical Journal - a warning against marriage between people at atomic plants. This was based on the assumption that radiation might affect heredity - which might be more acute if both husband and wife had been submitted to radiation.

The Oak Ridge response is to point at a lot of youngsters, children of the citizens of atom town. The birthrate at Oak Ridge is much higher than average - three-and-a-half times the figure of the nation at large. That's because so many of the workers there are young people. There's an abundance of children - and no sign of mal-formation, not the slightest hint of any radiation effect on heredity.

Actually, the scientists point out that at Oak Ridge the people are ~~subject to~~ less radiation than folks at Denver, for example. Because Denver is at ~~much higher~~ altitude - and ~~were~~ submitted to ~~cosmic radiation~~, I suppose. In any case, Oak Ridge is laughing at - the British Medical Journal.

WINDSOR

In any great story, the climax may have more than one aspect. There might be, for example, a political phase. Also - the human angle. And so it is in that spectacular drama of royalty and romance, more than a dozen years ago - the abdication of Edward the Eighth. Right now, the former monarch is telling his own personal story in Life Magazine, and this week's installment, just out, brings the climax. In which those two aspects, political and human, are striking.

Edward the Eight~~s~~, sovereign of the British Empire, had to face - first the prime minister, then the Queen Mother. His momentous interview with Stanley Baldwin has been related time and again - the prime minister himself giving an account in Parliament. But, that intensely human angle of son and mother - is now described for the first time.

The Duke of Windsor tells how, immediately after his interview with the prime minister, he felt he'd better present his case to the Queen Mother at once - before she received a distorted version. So he went to

Marlborough House - and there found his sister, Princess Royal Mary, as well.

"I settled down in a chair," relates the Duke, "and told them the whole story of my love for Wallis - and my determination to marry her."

He says that neither his mother nor his sister spoke any reproof. In fact, they sympathized - but they were thrown into consternation by his declaration that, if he were not permitted to marry Mrs. Wallis Warfield Simpson, he was prepared to abdicate the throne.

"My mother," he says, "had been schooled to put duty, in a stoic Victorian sense, before everything else in life. The word 'duty' fell between us." His view was that he had no intention of shirking his duty, but merely believed that a king should have a right to marry whomever he pleased.

Then he made a request to his mother and sister. "Please," he asked "won't you let me bring Wallis Simpson to see you? If you were to meet her, you would then understand what she means to me and why I

cannot give her up."

He says he did not believe this request would be refused, but it was. The Queen Mother and the Princess Royal had no inclination to receive the American woman - who had been divorced, and could never be queen.

"They," the Duke explains, "could not bring themselves to unbend even this much - not, I am sure, because they were wanting in sympathy. But, rather, because the iron grip of convention would not release them."

Nor has it ever released them - and to this day the royal family has never consented to receive the Duchess of Windsor
