The Yalta papers will provide no end of discussion - for a long time to come. Discussion - by the public, the politicians, the historians.

There's too much in the serit serit semoranda - to be summarized briefly. Sollet's take a look at the principal scene. The most critical one considering the state of the world just now.

The documents show that, weeks before Yalta, President Franklin D. Roosevelt received a secret memoranda from Averill Harriman. Now - Governor of New York. Then - U.S. Ambassador to Moscow. In this, Ambassador Harriman informed F.D.R. - that Soviet Russia was prepared to enter the war against Japan "with full power." Then, when Roosevelt, Churchill. and Stalin met at Yalta - Stalin laid down conditions. Making demands - which would have to be met before the Soviets entered the war against Japan.

At the same time, President Roosevelt had been urged by the U.S. Chiefs of Staff, to persuade Soviet Russia to enter the Far Eastern war as soon as possible.

The crucial event was a conversation between Roosevelt and Stalin, by thenselves - in February of nineteen forty-five - ten years ago. Stalin and Roosevelt going into the question of the Russian demands.

Stalin wanted the southern half of the large islands of Sakhlin. Also the Kurile Islands just north of Japan. F.D.R. said that there would be no trouble about that.

The large question was - Manchuria. Which

Japan had seized from China. The key point - the port

of Dairen. F.D.R. talking to Stalin, noted that Kussia

wanted a warm water port.

Which, indeed, had been the ambition of the Mussian Czars from time immemorial. F.D.R. suggested the soviets might get Dairen, under a lease. He added that he had not consulted the Chinese government of Chiang Kai Shek about this. In the end the soviets got Dairen. Also Manchurian Port Arthur for a naval base. Stalin wanted control of the Manchurian Railroads, and got them, under a lease. F.D.R. said he hadn't consulted Chiang Kai Shek about that either.

They were dealing with property guaranteed to Nationalist China. But President Roosevelt said that if the Chinese Nationalists were consulted about Russia's enterance into the war against Japan, the word would soon spread. Stalin agreed. Anyway, the agreement was - that the consent of Chiang Kai Shek would be obtained later on. Well, it was, after the

deal had been made without their knowledge.

The Soviets, through the harbor and railroad arrangement, got control of Manchuria - which they, later on, turned over to the Chinese Reds.

Russian

Control of Manchuria - figuring large in the Communist conquest of all China.

At that Yalta conversation, between Roosevelt and Stalin - British Prime Minister Winston Churchill was, of course, not present. Which was just as well.

Because F.D.R. suggested to Stalin that Nationalist

China might be compensated by getting Hong Kong. He thought that Great British colony could be given to the Chinese - in the form of an International harbor.

F.D.R. made a remark to Stalin that Churchill would probably object. Well, he sure would.

The documents show that, later on, at Yalta the suggestion was made that United Nations should have
a trustee-ship "over Colonial possessions." To which

Churchill replied heatedly that he would not have may anybody meddling in the vital concerns of the British Empire.

One interesting fact about the secret papers, now made public, is that part of the information is based on memoranda made by Alger Hiss who, later on, was sent to prison, convicted of perjury in connection with Communist espionage. Hiss was an official in the U.S. Delegation at the Yalta Conference.

Werth after ten years, thank the secret negotiations ar Yalta are now - public property. Much material - for plenty of study.
